

Additional regulations - "The Fine Print"

Site Location and Size

The Stallholder's site will be allocated by the Market Manager. The Stallholder must keep within the boundaries indicated for the site.

Cooperation with Holders of Adjacent Sites.

Stallholders shall cooperate with and show courtesy to the holders of adjacent sites.

Vehicles

Vehicles are allowed on the road during stall set up but must be moved before 8.45am. Be considerate at all times with parking; do not impede driveway access and be aware that your customers will want to park close to the market.

Sale of Food

Food items offered for sale must be prepared in accordance with all relevant local authority requirements. Sale of live animals at the market is not allowed.

Rubbish

Rubbish bins are provided within Memorial Park for public use only. Stallholders must remove all their own rubbish from the site following closure of the market.

Dogs

Stallholders are not allowed to bring dogs to the market for reasons of stall hygene. All dogs visiting the market must be restrained on a leash.

No Faked Goods

No stallholder shall sell counterfeit goods or goods with pirated brand names protected by local or international copyrights.

Damage

The Stallholder agrees to pay Carterton Farmers' Market, Carterton District Council or any other

applicable property-owner the cost of repair of any damage to property caused by any act or omission of the Stallholder and/or its staff.

Permission to Use Site Personal to Stallholder

The permission to use the site allocated to the Stallholder by the Carterton Farmers' Market Manager is personal to the Stallholder and cannot be transferred to another person; shared stalls are possible, please ask for more information.

Refund of Fees

Refund of stall fees paid in advance where the stallholder cannot attend due to unforeseen circumstances is at the discretion of the Market Manager.

Indemnity

The Stallholder agrees to indemnify and keep indemnified Carterton Farmers' Market against all claims, costs, expenses and losses made or brought against Carterton Farmers' Market by other persons in respect of damage to property caused by any act or omission of the Stallholder and/or its staff.

Waiver

Carterton Farmers' Market will not be responsible for any damage to, loss or theft of the Stallholder's property.

Matters Not Covered by Terms and Conditions

Where an issue arises that is not covered by these terms and conditions a decision made by the Carterton Farmers' Market Manager shall be final and binding on all Stallholders affected by it.

Right to vary terms and conditions

Carterton Farmers' Market reserves the right to vary these terms and conditions from time to time and all changes will be binding for all vendors. The current terms and conditions will be displayed on the Carterton Farmers' Market website: http://www.cartertonmarket.co.nz

Heath & Safety

Gazebos, Covers & Awnings

Vendors are required to ensure all equipment is properly anchored in the interests of public, vendor and staff safety. Due to under-grass watering system no stakes are allowed in the grassed areas to hold gazebos down. Use 20 litre water containers instead. There is a water tap on site.

First Aid

The Carterton Farmers' Market has a first aid kit available for the use of all stall holders. We strongly suggest that you pursue a certificate in first aid for the general safety of your customers at the Carterton Farmers' Market.

Electrical cords

All electrical cords must be suitably covered to prevent a trip hazard.

Defibrillator

The closest defibrillator is at the Mobile Gas Station on High Street, just North of the market.
