Outside Market

The Carterton Farmers Market is an all-weather outdoor market. Gazebos must be situated on the paved areas of Memorial Square. Mats must be used on the grass. You may bring your own or use the CFM mats, located on the trailer, stationed in Pete's Creative Kitchen's driveway. Please <u>do not use the grassed areas</u> without a mat.

This is a CDC requirement.

Stallholder Terms and Conditions

Registration

All stallholders **must register** prior to market attendance. Registrations **must be received** on the **Thursday** before your attendance day. **This is a CDC requirement.**

Payment of Site Fees

Site fees are payable at rates set by the Carterton Farmers' Market Executive Committee Changes in site fees will be advised with one month's notice.

Carterton Farmers' Market prefers payment by Internet banking.

Please use your business name and invoice number as a reference.

Registered Casual stallholders may pay cash to the site manager on Sunday.

This does create more work for the volunteer committee, so please make the effort to pay by internet banking.

Notification of attendance

Please inform us by Thursday of your plan to attend. We like to advertise our sellers by Saturday morning.

Days of Operation

The market operates every Sunday except for **Christmas Sunday**. **New Year's Day** opening is decided by a consensus of stallholders.

Hours of operation

Market hours are: 9.00 am to 12:30 pm.
Stallholder Set Up: Before 9.00 am
Stallholder Pack Up: 12:30 pm.

Thank you for keeping to these times, our customers expect consistent hours.

Regulations

Carterton Farmers' Market operates in accordance with relevant regulations including: Trading Standards, Environmental Health, Occupational Health & Safety, Liquor Licencing and Carterton District Council conditions.

Certification

Vendors must display in a prominent position:

Food Hygiene Certificate, Bio Grow or other Organic Certification you hold. Vendors may not advertise goods as organic unless appropriate certification is held. Failure to follow this rule will result in suspension from the market.

EFTPOS

CFM does not have EFTPOS facilities. There is a Westpac ATM on Belvedere Road, BNZ ATM on High Street and ANZ ATM at "Take Note Carterton" High Street Your own bank can provide ATM services on your smart phone.

Electricity

Vendors must provide their own generator if you require electricity. Please consider the public and other stallholders in the placement of your generator Health and safety issues are always a priority.

Stallholder Terms and Conditions – continued

Livestock

Sale of live animals is not allowed in the market.

This is a CDC regulation.

Gazebos, Covers & Awnings

Food vendors must shade their products. This is a Food Licensing requirement.

Vendors must anchor awnings, etc. with containers filled with water. Stakes are not allowed.

A water tap is on site.

Grass Mats

Supply your own or use the **CFM** mats. Mats must be returned to the trailer at the close of the market.

Please use the mats always. If you damage the grass you will be liable for the cost of repair.

This is a CDC requirement.

Advertising and Promotion

It is your responsibility to promote your business.

CFM will assist you in the following ways:

Posting a weekly Facebook Event for the Market

Advertising special promotions like "Daffodil Festival" Annual Plant Sale," New Year's Day Opening, etc.

Advertising in local newspaper and radio as the budget allows.

Targeted FB posts about your business. You must supply FB or Website links for pictures, etc.

Advertising your stalls on the CFM Website. You must provide us with your preferred information.

Writing a monthly column in the Carterton Crier, as time allows.

Keep your stall area clean and clear of all hazards, return the grass mats to the trailer, remove all rubbish and clean your area before you leave the market.

Smoking is not permitted within the market grounds.

Complaints Process:

Stallholders, please try to resolve any issues between yourselves.

If this is unsuccessful speak to the Market Manager.

The Market Manager will assess the situation and make a final decision.

The involved parties <u>must</u> comply with the Market Managers recommendations.
